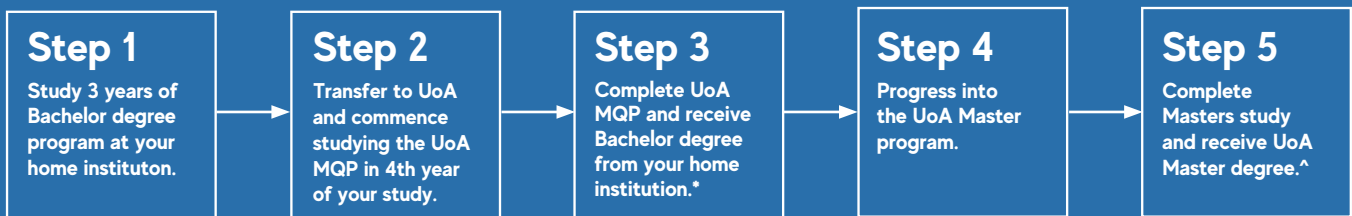
## Master Qualifying Program (MQP)

The MQP will provide you with the knowledge and skills required for successful completion of a Master level program at the University of Adelaide.

- The MQP is a one-year full time program offered to international students whose home institution has a formal agreement with the University of Adelaide.

- Enables early entry into the University of Adelaide postgraduate courses which can be counted towards the Bachelor degree at your home institution.
- The completed MQP is counted towards the destination Master program at Adelaide.
- Through this pathway a Bachelor and Master qualification can be completed in 5 years.

## Entry Requirements for MQP

- Enrolled at an institution with a formal MQP agreement with the University of Adelaide.
